This is to certify that I have registered an underage boy/girl for the Babies' Race / Teens' Race/ Family Run/Playground at Bucharest 10k& Family Run and I hereby state, acknowledge and agree to the following:

I am fully aware of the risk and responsibilities entailed by the participation of the underage boy/girl at Bucharest 10k& Family Run which I undertake entirely.

1. This declaration stands as my consent for Bucharest Running Club and the organizers' partners or sponsors to use the name of the underage boy/girl, their personal data, photos, video and quotes for promotional and/or marketing purposes.
 2. I hereby take on all risks related to the underage boy/girl's participation.
 3. This is to certify that the underage boy/girl is fit, has properly trained for the participation in the event and has not been advised against participation to this event by a medical doctor.
 4. I hereby declare my express consent for providing to the underage boy/girl any medical treatment that might be deemed opportune in case of injury, accident or disease during the event.
 5. I hereby confirm that the underage boy/girl is medically fit and in good shape to attend such a strenuous event, namely the Babies'Race/Teens' Race/ Family Run at the Bucharest 10k& Family Run , therefore I hereby exempt the organizers, as well as anyone related to the organizers (sponsors, partners, employees, authorities, officials, volunteers etc.) of any liability related to any claims I might have, either myself or my successors, for potential injuries, diseases or any other medical problems that might occur during the race they attend.
 6. I hereby declare that, should the events described at point 4 occur during the competition and should the first aid personnel, services and transportation be insufficient or unable to cover the potential needs of the underage boy/girl in my custody, I commit to bearing all costs related to the potential treatment and/or transport to/from a specialized healthcare unit and I hereby declare that I relinquish any potential claims regarding such emergency transportation and/or treatment, delays or related deficiencies.
 7. I hereby declare that I am aware that throughout the event, there might be incidents due to the negligence of entities or individuals organizing the event, related to the improper use of equipment or goods owned, kept or controlled by them, incidents that might prove to be dangerous for the underage boy/girl and that might physically and/or materially harm the underage boy/girl and I hereby declare that I exempt the organizers, as well as anyone related to the organizers (sponsors, partners, employees, authorities, officials, volunteers etc.) of any liability with regard to any claims I might have, either myself or my successors.
 8. I also exempt the organizers, as well as anyone related to them (sponsors, partners, employees, authorities, officials, volunteers etc.) of any liability regarding any claims I might have, either myself or my successors, for potential theft/loss of my possessions that might be perpetrated at this event.
 9. I hereby declare that I received the race kit for the underage boy/girl (the race kit is delivered on the race day)
 10. I hereby understand and agree that the race participation/registration fees that I paid are not refundable and not transferable.
 11. Bucharest Running Club Association reserve the right of cancelling the event or changing the event date, as well as any other details related to the event.
 12. I have read and understood all of the aforementioned information and I hereby express my agreement by signing this declaration.
 13. Hereby, I declare that I have been informed on my rights provided by (EU) REGULATION 2016/679 of the EUROPEAN PARLIAMENT and of the COUNCIL of 27 April 2016 on the protection of individuals with regard to the processing of personal data concerning the free movement of such data And repealing Directive 95/46/EC (data protection regulations) (see the website of the national authority for the protection of Personal data, the COUNCIL REGULATION (EU) 2016/679) concerned the right of access to data, to rectify, "right to be forgotten", the right to restrict the right of opposition, the right to data portability, the right not to be subject to decisions based solely on automated processing, including the creation of profiles. At the same time you have the right to oppose the processing of your personal data and to request deletion, within the limits of the legal provisions in force. - The undersigned, acting as parent/legal guardian of the underage child that I accompany, aware of the legal provisions in force regarding the liability of the person who, according to the law, must supervise an underage child, hereby declare that all underage children under my supervision are medically fit (according to the oral/written statutory declaration given to me by their parents/guardians) to attend this event and I take full responsibility for all risks described in this declaration, that might occur and affect the underage children in my care and for whom I am legally responsible.
